Explanation of Responses:

1. On October 31, 2012, the reporting person received a grant of Performance Stock Unit ("PSU") consisting of 36,000 Performance Stock Units tied to specific milestones to be achieved during the performance period of July 1, 2012 to June 30, 2014. One half of the shares vest upon certification of the performance criteria and the remaining shares vest on the first anniversary of the Vesting Date. All performance criteria were met, resulting in the certification of the performance criteria by the Comp. Committee on March 21, 2013, and the vesting of the PSU as to 18,000 shares. The remaining 18,000 shares will vest on the first anniversary of the Vesting Date.
